GIVE FROM THE HEART, BUT PLEASE GIVE SMART!

CHECK

Use the [Charities Search](#) feature on the Secretary of State's website at sos.sc.gov to check whether a charity is registered to solicit donations in South Carolina. You can look up a charity's financial information, including total revenue, total expenses, fundraising costs, and the percentage spent on charitable programs, as well as review a copy of the charity's most recently filed annual financial report.

ASK

If you are solicited for a donation, always ask:

- What is the name, location, and mission of the charity?
- How much of your donation will be used for program services?
- If you are being solicited by a professional fundraiser, how much of your donation will go to the charity, and how much will be used to pay for fundraising costs?

NOTIFY

If you have concerns about a charity or professional fundraiser, notify the Secretary of State's Office through the [Online Charitable Solicitation Complaint Form](#) at sos.sc.gov. You can use this form to file a confidential complaint 24 hours a day, 7 days a week. You can also contact the Division of Public Charities at charities@sos.sc.gov or 1-888-CHARITI (242-7484).

2020-2021 WISE GIVING REPORT

In order to promote accountability and transparency in charitable fundraising, Secretary of State Mark Hammond is publishing the 2020-2021 Wise Giving Report of the Division of Public Charities. Pursuant to the South Carolina Solicitation of Charitable Funds Act, the Secretary of State's Division of Public Charities regulates charitable solicitations in this state. Some charitable organizations use professional or paid fundraisers to solicit donations on their behalf.

The 2020-2021 Wise Giving Report has two sections: the [Give Smart Watch List](#) and the [Professional Solicitor Report](#). The purpose of the Give Smart Watch List is to alert South Carolinians to organizations that may be asking them for donations, but that have either reported spending less than 40% of their total expenses on their charitable programs or that have failed to disclose to donors how they are using their money. The Professional Solicitor Report offers a comprehensive listing of financial data from joint financial reports and fundraising contracts filed with the Division of Public Charities in 2020 and 2021.

Both the Give Smart Watch List and Professional Solicitor Report serve to remind members of the public to always [check](#) on charitable organizations that solicit donations from them, [ask](#) questions of the person or entity soliciting the donation, and [notify](#) the Secretary of State's Office if they have any concerns or complaints about the solicitation.

2021 GIVE SMART WATCH LIST

The organizations included in the Give Smart Watch List have reported spending less than 40% of their total expenses on their charitable programs, or have failed to disclose to donors how they are using their money. For reference, the Better Business Bureau cautions donors from contributing to any charity that spends less than 65% on its program services.

The information provided is based on information that has been filed with the Secretary of State's Office, is contained in court documents, or is otherwise publicly available. Childhood Leukemia Foundation, Inc., Brick, New Jersey

The mission of Childhood Leukemia Foundation is to educate, empower, and lift the spirits of children in the United States suffering from cancer.

The organization's program services include providing iPads and Wish Baskets (containing educational material and a \$75.00 gift card) to childhood cancer patients, as well as wigs through its "Hugs U Wear" program. The organization also provides "Hope Binders" to the families of children with cancer to record medical information and track and prioritize medical expenses.

In FY 2020, this organization reported spending only **16.9%** of its total expenses on charitable programs. For every dollar it raised, the organization spent \$0.77 on fundraising expenses.

Disabled Veterans National Foundation, Lanham, Maryland

In FY 2019, DVNF reported spending **22.7%** of its total expenses on charitable programs, which include providing financial support to veteran organizations and gifts-in-kind to homeless and low-income veterans. Despite raising over \$27 million in FY 2019, the organization reported providing only \$1.87 million in cash and non-cash grants to domestic organizations and individuals—less than 7% what it raised that year.

The organization also lists exchanging ideas and information, identifying areas of concern to veterans, and developing recommendations for legislative, programmatic and outreach activities as program services. In FY 2019, the organization spent over \$4.3 million on a combined educational and fundraising campaign. Without this joint cost allocation, DVNF's program expense percentage would have been 6.97%.

Firefighters Charitable Foundation, Inc., Farmingdale, New York

In FY 2019, Firefighters Charitable Foundation, Inc. reported spending only **12.2%** of its total expenses on charitable programs.

This organization's charitable purpose is to provide financial assistance to persons affected by a fire or disaster. It reported giving less than \$84,000.00 in grants to domestic organizations and \$67,000.00 to individuals—a mere 4.4% of its total expenses in FY 2019. Instead, the organization spent nearly \$2.7 million on fundraising expenses. In FY 2019, the organization contracted with 10 different professional fundraisers, and it currently has three active fundraising contracts in South Carolina.

The president and secretary/treasurer of the organization are married.



Law Enforcement Officers Relief Fund, Sarasota, Florida

The stated purpose of this organization is to assist law enforcement and their families when tragedy strikes.

In FYE 2020, the organization reported spending **9.5%** on program services. Even though the organization raised over \$1.2 million that year, it spent only \$9,250.00 on grants to domestic organizations and \$22,000.00 in cash grants benefitting six individuals. Its other program expense was \$85,000.00 for a conference. In contrast, the organization spent 85% of its total expenses on fundraising.

This organization does business under the names "National Patrolmen's Foundation" and "Police and Troopers Relief Foundation."

Military Order of the Purple Heart Service Foundation, Annandale, Virginia

This organization's mission is to enhance the quality of life for all veterans and their families, providing them with direct service and fostering an environment of goodwill and comradery.

In FYE 2020, this organization reported spending just **7.3%** of its total expenses on charitable programs. Despite collecting over \$20 million in cash and non-cash contributions, this organization reported spending just \$1.05 million for veteran service grants to organizations. It also reported spending approximately \$450,000.00 on its veteran service program, which provides funding for jobs and other services for veterans and their families. Nearly 85% of the organization's expenses in FYE 2020 were fundraising costs.

This organization also does business under the names "Purple Heart" and "Purple Heart Foundation."

Miracle House of Hope Ministries, Charlotte, North Carolina

This organization claims to assist recovering drug addicts by providing housing and employment, and typically solicits contributions from motorists in busy intersections. Unfortunately, there is no way to verify what this organization does with the money it collects because it refuses to file annual financial reports. In March 2019, this organization was enjoined from soliciting in the state of South Carolina by order of the South Carolina Administrative Law Court. In October 2019, it was held in contempt of court for violating the injunction, and a bench warrant was issued against its CEO. Presently, it owes over \$12,000.00 in administrative fines for failure to comply with the South Carolina Solicitation of Charitable Funds Act. Despite these actions, the Secretary of State's Office periodically receives complaints about the organization soliciting within the state—most recently in Greenville, Richland and Spartanburg Counties.



National Cancer Assistance Foundation, Inc., Daytona Beach, Florida

In FY 2019, this organization reported spending **30.2%** of its total expenses on charitable programs.

This organization's main programs are providing direct financial assistance to cancer patients and promoting awareness of the effects of cancer, as well as the need for early detection. In FY 2019, NCAF awarded \$380,216.00 in grants and other assistance to 735 individuals. This equated to an average of \$517.00 per person, and less than 9% of the organization's total expenses that year.

Of the \$1.28 million the organization reported spending on program expenses, \$724,061.00 was spent on a combined educational and fundraising campaign. Without this joint cost allocation, the percentage spent on program services drops from 30.2% to 13.2%.

Project Cure, Inc., Lakewood Ranch, Florida

Project Cure's primary program service is educating consumers, health professionals, and policymakers on alternative, "non-mainstream" medicine through letters, phone calls, reports, brochures, e-books, PDF downloads, websites and social media. It does business under the names "Alzheimer's Disease Fund," "National Diabetes Fund," and "Prostate Cancer Fund."

In FY 2020, this organization reported spending **27.4%** of its total expenses on charitable programs. Over half of these expenses were for a combined educational and fundraising campaign. Without this joint cost allocation, its program expense percentage would be 12.1%.

According to Project Cure's annual financial report, the organization's president received a loan from the organization in the amount of \$217,336.00.

Retired Police Canine Foundation, Inc.,
Weeki Wachee, Florida

This organization's purpose is to provide medical care for police and military service dogs, and educate the public about the special needs of service dogs.

In FYE 2020, the organization reported spending **28.3%** of its total services on program services. It reported spending \$11,902.00 on K-9 supplies; \$31,535.00 on medical expenses; \$316.00 on K-9 airline expenses; and \$2,794 on K-9 cremation—which amounted to less than 5% of the organization's total expenses. In contrast, nearly \$195,000.00 of costs allocated as program service expenses were for a combined educational and fundraising campaign.

The organization also operates under the name "Help Our Military and Police Dogs."

Walker Cancer Research Institute, Inc.,
Boynton Beach, Florida

The stated purpose of this organization is "cancer research and public information." It uses the d/b/as of National Breast Cancer Research Center and National Cancer Research Center.

In FY 2019, this organization reported spending **35.2%** of its total expenses on program services; however, many of the listed program expenses were for combined educational and fundraising campaigns. Without this joint cost allocation, the organization's program service expense percentage would be just 9.6%. The organization reported raising \$4.1 million in revenue in FY 2019, but it spent less than \$430,000.00 on cancer research.

According to its FY 2019 annual financial report, the organization received over \$47,000.00 in list rental income.

PROFESSIONAL SOLICITOR REPORT

Prior to starting a fundraising campaign, professional solicitors are required to file a notice of solicitation and fundraising contract with the Division of Public Charities. At the conclusion of a fundraising campaign, or each year of a multi-year campaign, a professional solicitor is required to file a joint financial report with the Division of Public Charities. The joint financial report must be signed by both the professional solicitor and the charitable organization, and must disclose the gross receipts from the campaign, the itemized expenses incurred by the professional solicitor, and the total amount remitted to the charitable organization. This report provides a comprehensive listing of the data provided in joint financial reports filed by professional solicitors during 2020, and a listing of all active fundraising contracts as of October 1, 2021.

Part I of the Professional Solicitor Report lists in alphabetical order each charitable organization for which a joint financial report was filed in 2020. The report then lists all professional solicitors employed by the charitable organization, along with the fundraising methods used by the professional solicitor; the date the joint financial report was filed; the dates of the fundraising campaign covered by the joint financial report; the gross receipts from the campaign; the amount remitted to the charity; and the percentage of the gross receipts that the charity received.

PROFESSIONAL SOLICITOR REPORT

Part II of the Professional Solicitor Report lists in alphabetical order each professional solicitor with an active fundraising contract on file with the Division of Public Charities as of October 1, 2021. The report then lists each charity client of the professional solicitor for which a contract was filed, the dates of the solicitation campaign, and either the minimum guaranteed percentage of gross receipts to be remitted to the charity based on the contract, or other terms of remuneration.

Although each charitable organization and professional solicitor referenced in this report was registered with the Division of Public Charities to solicit donations in South Carolina at the time the fundraising campaigns were conducted, many of the joint financial reports and contracts were for national campaigns. Therefore, it is important to note that the reported gross receipts reflect donations from all solicited persons, not just South Carolinians. Furthermore, the data presented in the Professional Solicitor Report does not reflect how much the charitable organizations spent on their program services.
